



## V-ROADS Newsletter Data Protection Notice

**(Art. 13 of Regulation (EU) 2016/679 – General Data Protection Regulation “GDPR”)**

In compliance with the requirements of the General Data Protection Regulation, the Data Controller, Fondazione Flaminia, provides the following information regarding the processing of personal data carried out in the context of the V-ROADS newsletter activities.

### **PURPOSE OF THE PROCESSING AND LEGAL BASIS**

Providing your personal data (Name, E-mail address) through the dedicated form is necessary to receive the V-ROADS newsletters, which contain invitations to events, project updates, and information on pilot training courses.

For this purpose, your explicit and freely given consent is required, which may be expressed by selecting the dedicated checkbox in the form.

Your data will be used solely for sending this type of information. You may unsubscribe at any time and stop receiving further communications by clicking the dedicated link included in each newsletter, thereby exercising your opt-out right.

Personal data will be processed exclusively for purposes related to the V-ROADS project and may be accessed by authorized staff of Fondazione Flaminia and, where necessary for project communication and dissemination activities, by authorized project partners involved in the management of the newsletter and stakeholder communication activities. Data will not be disseminated or used for commercial purposes.

Personal data are not subject to profiling or automated decision-making processes and are not transferred to non-EU countries or international organizations.

### **DATA RETENTION**

Contact data collected for sending communications and newsletters will be stored and used until the data subject exercises the right to opt out and requests no longer to be contacted.

### **RIGHTS OF THE DATA SUBJECT**

With regard to the above-mentioned processing activities and the related data stored in our archives, you may exercise the rights provided for in Chapter III, Articles 15 to 22 of Regulation (EU) 2016/679, including in particular:

- Right of access (Art. 15)
- Right to rectification (Art. 16)
- Right to erasure (“right to be forgotten”, Art. 17)
- Right to restriction of processing (Art. 18)
- Right to data portability (Art. 20)
- Right to object (Art. 21)

**RIGHT TO LODGE A COMPLAINT WITH A SUPERVISORY AUTHORITY**

Pursuant to Art. 13(2)(d) of the GDPR, you are informed of your right to lodge a complaint with the Italian Data Protection Authority (Garante per la Protezione dei Dati Personali) if you believe that your rights as a data subject have been violated or if you have concerns regarding the processing of your personal data.
